

# Charging and Remissions Policy

## **Introduction**

The principle of free education for all is central to the 1944 Education Act. However, it is recognised that, whilst wishing to provide additional and enriching experiences for all pupils, the funding available is not always sufficient to do so without asking for contributions from those able to make them.

This policy is based on advice from the Department for Education (DfE) on charging for school activities and the Education Act 1996, sections 449 to 462 of which set out the law on charging for school activities in England. Academies are required to comply with this Act through their funding agreements.

It's also based on guidance from the DfE on statutory policies for schools and academy trusts.

This policy complies with our funding agreement and articles of association.

## **Voluntary Contributions**

Many activities undertaken at school can only happen because parents have contributed either to the cost, or by the provision of materials, ingredients, equipment, etc. The school is able to ask for voluntary contributions from parents to fund activities which would not otherwise be possible. Legislation establishes that the restrictions on charging for school activities do not in any way prohibit or restrict the school from seeking voluntary contributions for the benefit of the school or in support of any school activity, whether during or outside school hours, residential or non-residential.

If sufficient voluntary contributions have not been received, then the activity may not take place. Such contributions will be genuinely voluntary and the terms of the request will make clear:

- That there is no obligation to contribute;
- That no pupil will be treated differently according to whether or not his or her parent has contributed in response to the request.

The criterion governing any contribution or charge will be that no profit will be made. At all times, we will try to ensure that a pupil's educational experience is not diminished by financial hardship.

## **1. Charging**

Charging can be made for the following areas of activity:

- The proportionate cost of a residential visit (i.e. total cost / number of children = charge);
- The proportionate cost of a school day trip / event (i.e. total cost / number of children = charge);
- Costs associated with individual tuition in the playing of a musical instrument, whether in or out of school hours;
- After School Activities;
- Breakfast Club
- Concert tickets;
- Extra-curricular activities.

Payment from parents will be sought for damage to, or loss of, school property, caused wilfully or neglectfully by the children.

## **2. Remissions**

For those pupils who are in receipt of Free School Meals or due to exceptional circumstances, the board and lodging costs of a residential visit may be remitted (by application to the Headteacher) if:

- a. The activity takes place during school hours; or
- b. The activity takes place outside school hours but is necessary for one of the following reasons:
  - i. To fulfil statutory duties relating to the National Curriculum;
  - ii. To fulfil statutory duties relating to Religious Education.
